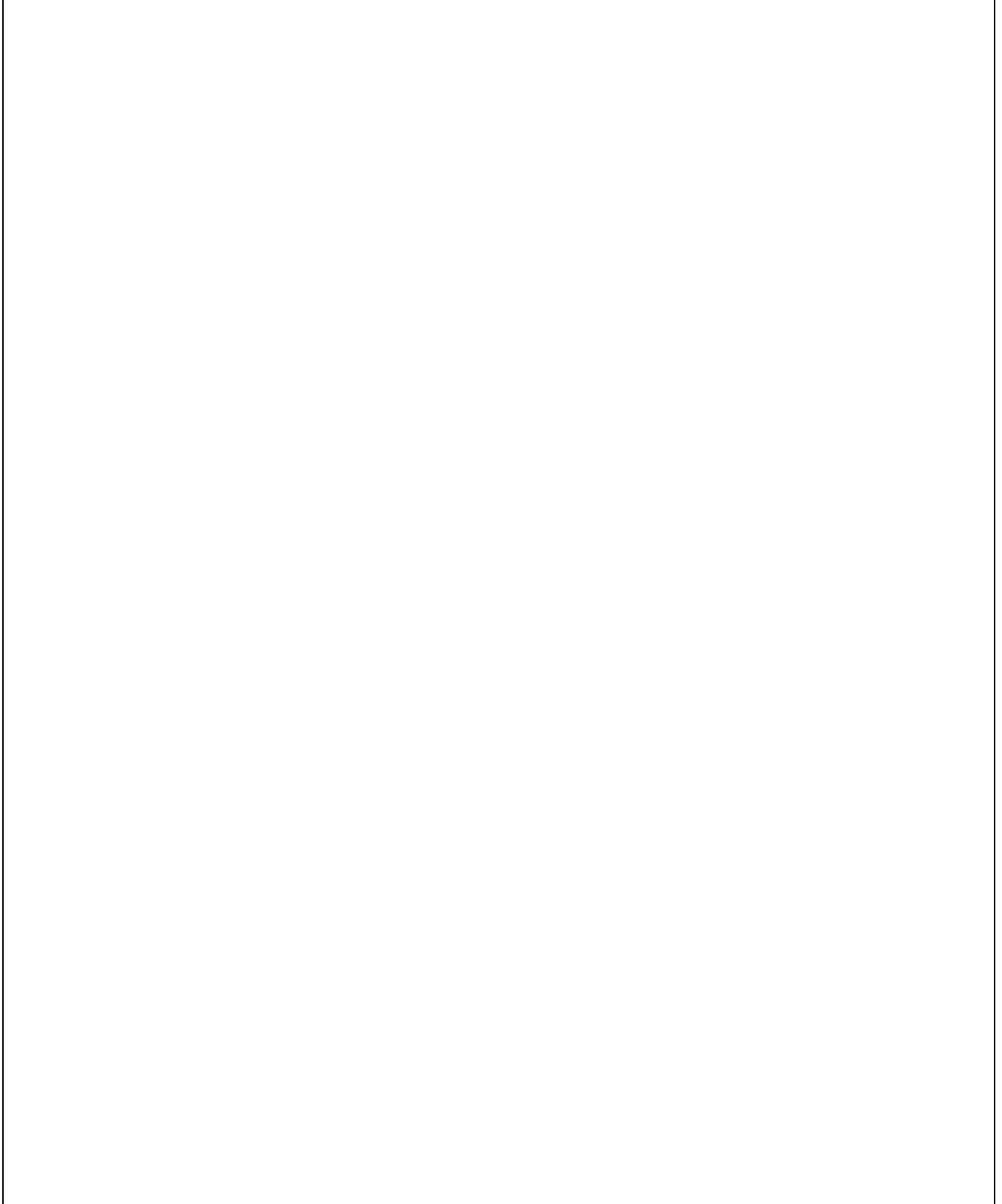

Plot plan showing location of the Mobile Food Facility or Booth when parked or located on land, including setbacks from the Mobile Food Facility or Booth to the property lines (front, side and rear) and the location and number of designated parking spaces for the Mobile Food Facility or Booth.

Copy of the license issued to the Mobile Food Facility or Booth by the Pennsylvania Department of Agriculture.

Copy of a current Food Handler Certificate issued by ServSafe to the person who will be operating the Mobile Food Facility or Booth.

Copy/proof of Comprehensive Public Liability Insurance (not less than \$300,000).

Copy/proof of Workers' Compensation Insurance or an affidavit that the Owner has no employees.
